I certify that I am the owner of this pet, that I am eighteen years of age or older and have the legal capacity to enter into a binding contract. I am the owner of the pet, or if I am not, I have advised Gus's Day Diggs Inc. of who the owner(s) is (are) and am authorized to act on their behalf. I further certify that I have read and understand the rules and regulations as set forth in this agreement. I agree to abide by the rules and regulations and accept all the terms, conditions and statements of this agreement.

I hereby release Gus's Day Diggs Inc., its owners, employees, volunteers and agents from any and all liability which I, the pet, any third party person or their pet may suffer, including specifically, but not without limitation, any injury or damage whatsoever arising from my actions or failure to act, the pets actions or generally the pets attendance and participation at Gus's Day Diggs Inc..

I hereby agree to indemnify and hold harmless Gus's Day Diggs Inc., its owners, employees, volunteers and agents from any and all claims, or claims by myself or any third party accompanying me to a function of Gus's Day Diggs Inc, or while attending the premises thereof, as a result of any actions or failure to act by me or by my pet.

I hereby represent that the pet is of good health and has not been ill with any known contagious diseases within the last 30 days.

I recognize that the health of the pet is my personal responsibility. I hereby represent that all required vaccinations for the pet are up to date and will continue to remain as so for as long as the pet is attends Gus's Day Diggs Inc.. I will promptly provide proof of all booster vaccinations to Gus's Day Diggs Inc..

I further understand and agree that in admitting the pet, Gus's Day Diggs Inc. has relied on my representation that the pet is in good health and has not harmed or shown aggression or threatening behavior towards any person or any other animal. It is the owner's responsibility to inform Gus's Day Diggs Inc. of any previous bite history, medical or behaviour issues before the pet is admitted into the facility. If another animal or member of the staff is injured as a direct result of negligence on this part, the owner will be made responsible for medical and restoration fees incurred.

I understand that by bringing my pet to a partially open concept care facility means that my pet will be playing and interacting with other pets. Minor cuts or scratches are inevitable, and, though the pets are carefully supervised and monitored at all times, and the owners, staff and volunteers do their utmost to keep them safe, there is no warranty or representation by Gus's Day Diggs Inc. that a more serious incident (scuffles, fighting, even death) will not occur. I accept the risk of any such more serious incident happening.

I further understand and agree that Gus's Day Diggs Inc. and its caregivers will not be liable for any problems that might develop with the pet, including, but not limited to, sickness, disease, injury, running away and death, provided that reasonable care and precautions have been followed.

For the safety of all our four-legged friends, should a transferable medical issue arise e.g. lice, kennel cough, diarrhea, ringworm, vomiting, upper respiratory virus etc., the owner MUST inform Gus's Day Diggs Inc. immediately to prevent the transfer of infection.

In the event of a life threatening or serious emergency (at the discretion of Gus's Day Diggs Inc.) the pet will be taken to the nearest Emergency Facility or Vet Clinic with the cost being the sole responsibility of the myself, the pet owner. In the case where my pet is taken to an Emergency Facility or Vet Clinic I as the owner of the above described pet, give Gus's Day Diggs Inc. permission to allow treatment and give authority to sign for treatment on said pet. I understand that an attempt to contact either myself or the emergency contacts that I have given to Gus's Day Diggs Inc. will be made prior to the pet being brought in for any medical emergencies.

I understand I am solely responsible for any harm that my pet may cause to another pet while they are at Gus's Day Diggs Inc.. If for any reason, Gus's Day Diggs Inc. is unable to further care for the pet, I must have an emergency contact be available to pick up and care for the pet.

I further understand and agree that any problem(s) that may develop with my pet will be treated as deemed best by the caregivers of Gus's Day Diggs Inc. at their sole discretion and that I will assume full financial responsibility for any and all expenses involved.

I understand that my pet is to wear a collar and have all current ID tags while the pet is in attendance at the Gus's Day Diggs Inc.. I understand that I am to walk my pet in and out of the facility on a leash, and in a safe and expedient manner.

I understand that my dog is not allowed to bark uncontrollably while at Gus's Day Diggs Inc. and if necessary the dog will be muzzled or kenneled for short periods of time as a training tool. I also understand that in order

to maintain control and exhibit leadership in a large group, certain humane training and disciplinary methods may be used as the owners or staff of Gus's Day Diggs Inc. see fit given the circumstance.

Gus's Day Diggs Inc. fees are non-refundable and non-transferable. Fees for multi-day passes or package deals are to be pre-paid. Days purchased in packages/passes cannot be split into half days. Half day rates must be purchased separately. Gus's Day Diggs Inc. Pet Day Care fees are subject to change without notice. Multi-day passes purchased expire 6 months from date of purchase.

In the event of a discrepancy, the pet owner is financially responsible for all services rendered unless otherwise decided by the owners of Gus's Day Diggs Inc..

Gus's Day Diggs Inc. reserves the right to cancel or change activities and outdoor play time at their discretion for reasons such as weather, behavior issues, personal emergencies etc.

Gus's Day Diggs Inc. staff will take every precaution to ensure that your pet is secure and on leash when being walked or being transported to the outside play area. Gus's Day Diggs Inc. is not responsible for any pet that runs off during any activities that the pet is participating in whether it be inside or outside activities.

I agree that if my pet is videotaped, photographed, and/or recorded, Gus's Day Diggs Inc. Pet Day Care shall be the exclusive owner of said property and may use said property at their own discretion.

I understand that I must book a daycare reservation prior to arriving to Gus's Day Diggs Inc. and that a cancellation policy is in effect for daycare reservations. I understand that if I have a reservation and do not arrive (a "no show") or do not cancel by 8:00 am, I will be charged by Gus's Day Diggs Inc. or have that day deducted from my package if I have purchased one on my account.
